

SnoCope Credit Union “Guess the Score” Contest Prize Entry Rules February 2 – 8, 2026

1. **NO PURCHASE IS NECESSARY TO ENTER OR TO WIN.** This contest is open to SnoCope Members only 18 years or older, and is void where prohibited by law. Employees, Board Members and Supervisory Committee Members of SnoCope Credit Union are not eligible to win.
2. **HOW TO ENTER:** On February 2 – 8, 2026 (prior to 3:30pm PST) any person who is a member of SnoCope Credit Union will be eligible to win. Only One (1) entry per membership. Members may enter via email from the SnoCope website (<https://www.snocoope.com/home/guess-the-score>) and fill out the information that auto populates in the “CLICK-HERE” to email the SnoCope Marketing Manager, or copy the information on the web page and send in an email to tracey@snocoope.org. Or members may fill out a paper entry form at any Member Services window. SnoCope is not responsible for incomplete or illegible entry forms. Incomplete forms will be considered invalid.
